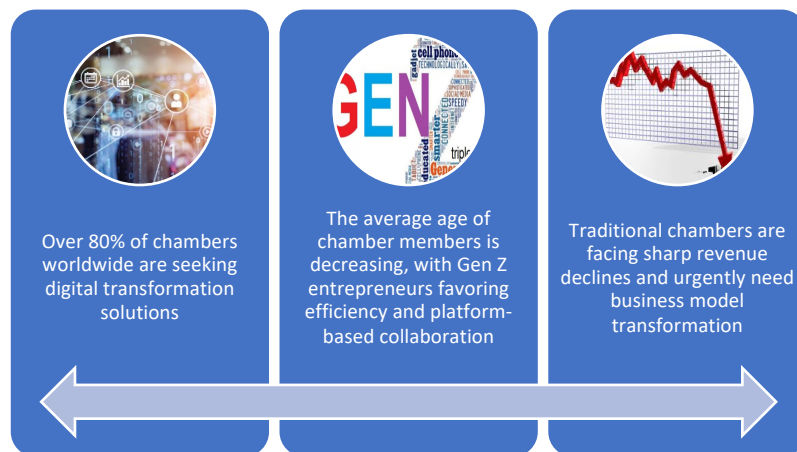


Chamber-Link 商会链 Honorary Partnership Support Program

1. Platform Positioning (Starting From 2025)

Chamber-Link 商会链 is positioned as the official digital platform led by the **World Lin Chamber of Commerce**, dedicated to promoting digitalization, technological advancement, and commercial connectivity across all Lin chambers globally.

The platform will **no longer open to the public or external chambers** at this stage. Instead, it will focus entirely on consolidating internal Lin chambers and business networks to create a private digital ecosystem for Lin entrepreneurs.

2. Honorary Partnership Support Mechanism (× Not equity-based、× not fundraising、× not crowdfunding)

We have moved away from traditional "investment" and "shareholder" models. Instead, we now offer **Honorary Partnership Support Packages**. Participants will be honored as

Honorary Partners of the Chamber-Link Privilege for the Lin Commerce Platform and
enjoy recognition, returns, and platform privileges.

Benefits for Honorary Co-Partners :

- Custom honorary certificate, officially awarded at the **World Lin Chamber Annual September Summit** with public recognition.
- Starting from Year 3, honorary co-partners will enjoy **annual profit-sharing rights**, with an **indicative return of up to 3%**, based on actual platform performance and earnings.
- This approach emphasizes **transparency, fairness, and compliance**, with all rewards derived from verified operational results.
- **Exclusive access to, but not limited to:** Priority homepage exposure, Early access to new features, Complimentary advertising credits or credit points, Priority listing in our "Business Hall of Fame" or B2B Opportunity Zones

4. Platform Revenue-Based Return Model (For Confidence & Transparency)

The annual profit return to all honorary co-partners is strictly based on the actual revenue generated by the Chamber-Link platform. Our business model is diversified and designed for long-term sustainability:

This model adopts a profit-sharing structure (not a fixed interest), ensuring transparency, ethical standards, and full Shariah compliance.

Main Revenue Streams:

- Chamber subscription fees (RM350/month per Lin chamber from 2026)
- Paid advertising & sponsored content (banners, videos, event ads)
- Merchant Listing Fees (company profile + product catalog)
- AI-powered Smart Promotion (credit point based)
- Event / course / project listing (credit point based)
- "Hall of Fame" / Top 100 Lin Enterprises (priority for partners)
- Mentorship System (partners can become paid mentors)
- Premium membership upgrades & international services

✦ All revenue and expenses will be transparently displayed in the APP under **[Public Financial Disclosure]**.

5. 5-Year Development Roadmap

- **2025:** Full integration of Lin chambers; First round of honorary partner recognition
- **2026:** All branches onboarded; subscription, advertising & AI engines launched
- **2027:** Launch of “Top 100 Lin Entrepreneurs” + Annual Global Chamber Digital Forum
- **2028:** Global Mentorship system launched
- **2029:** Expansion to overseas Chinese chambers; building international Lin brand

Note: This roadmap is a strategic guideline subject to real-time adjustment based on member feedback, market conditions, and platform progress.

6. Profit Sharing Mechanism (Starting Year 3)

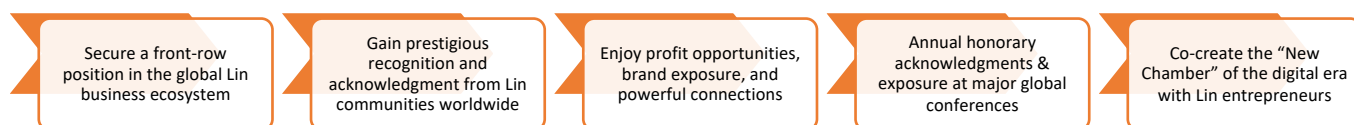
- All Honorary Co-Partners will, starting from the third year of participation, be entitled to a **profit-sharing arrangement**, based on the platform’s actual performance and earnings.
- **Indicative Returns:** An indicative return of **up to 3% annually**, subject to the platform’s performance.
- **Model Explanation:** This model adheres to **ethical, transparent, and Shariah-compliant principles**, ensuring fair treatment for all contributors.
- **Return methods:** cash payout / Platform Credit Points for services and ads / Priority exposure and honorary recognition
- From Year 4 onwards, if profitability is more than expected or the amount set, an **additional 5% bonus pool** will be shared among partners
- **Note:** All returns are calculated based on annual audited earnings to ensure transparency and legitimacy.

✦ **Example:** Support RM100,000 → from Year 3 (based on the platform's actual performance and earnings) = RM3,000/year (plus potential bonuses if profitability is more than expected or the amount set)

7. Special Platform Privileges

- **Hall of Fame Display:** Exclusive “Top Lin Entrepreneurs” section for partners
- **AI Promotion:** Smart matching to high-potential clients
- **Mentorship & Branding:** Be listed as mentor and offer paid consulting
- **Beta Access:** Early access to premium features (AI proposals, translation, data tools)
- **Business Profile Page:** Full tools for partner-brand representation
